Subj: DEPLOYMENT READINESS COMPLIANCE

Ref: (a) MILPERSMAN 1300-318
(b) BUMEDINST 1300.3A
(c) Bureau of Medicine and Surgery Individual Augmentation (IA) Business Rules

1. Purpose. In order to fully support the operational needs of the war fighter and achieve the highest level of Readiness, it is our responsibility to ensure that personnel who fall under the jurisdiction of Budget Submitting Office (BSO) 18 meet designated readiness standards. As such, it is the responsibility of each Navy Medicine (NAVMED) Region Commander to engage in deliberate planning efforts that create and sustain pools of personnel ready to deploy.
2. Applicability. This instruction applies to Bureau of Medicine and Surgery (BUMED), NAVMED Regions, and applicable subordinate commands.
3. Policy. References (a) and (b) provide guidance regarding medical, dental, and administrative screenings members identified for IA, Overseas Support Assignments (OSA), Global War on Terrorism Support Assignments (GSA), and TEMADD (where applicable) must complete. NAVMED Region Commanders shall ensure the personnel under their purview are fully compliant with references (a) and (b).
4. Organizational Responsibilities
 - a. Per reference (c), NAVMED Regions must identify a primary and alternate deployer for every tasked O-4 and below requirement. As such, NAVMED Regions shall:
 - (1) Ensure the primary and alternate deployers have completed the requisite medical, dental, and administrative screenings in accordance with references (a) and (b) within 20 days of tasking by BUMED-M3/5CS, Contingency Support.
 - (2) Via their NAVMED Region Plans, Operations, and Medical Intelligence (POMI) offices, ensure when a member is deemed non-deployable his or her status is relayed to BUMED -M3/5CS within 2 business days of the members date of disqualification by competent medical authority (e.g., date recorded by the provider on the members NAVPERS 1300/21, Medical Suitability Certification and NAVMED 1300/4, Expeditionary Medical and Dental Screening for Individual Augmentee (IA) and Support Assignments to Overseas Contingency Operations (OCO)) and replaced in accordance with reference (c).

b. BUMED-M3/5 Contingency Support shall monitor and track regional compliance with this instruction and provide reports regarding said compliance to BUMED-M3/5, Deputy Chief, Medical Operations/Future Operations upon request.
