

EFMP BASICS

WHAT is EFMP?

The Navy's Exceptional Family Member Program (EFMP) is a quality of life program that provides continuity of care for family members with special needs by ensuring that medical & educational needs are considered in the detailing process.

WHO is eligible?

Dependents who are:

- Enrolled in DEERS
- Diagnosed with chronic conditions requiring special services.
- Resides with the sponsor*

*exceptions for geographical bachelors & residential care facilities

WHEN should I enroll? IMMEDIATELY!

EFMP is a mandatory program. Allow 6 - 8 weeks for processing, which could delay your orders!



WHERE will I go?

Each assignment is considered on an individual basis, & every effort is made to match the sponsor's career path with the needs of the family.

WHY should I enroll?

- Mandatory!
- Improves quality of life & continuity of care
- Respite care for categories 4 & 5
- Preferential status for on-base housing
- Access to Tricare ECHO services
- Networking, information, referral, non-medical case management, system navigation, & individualized services plan
- Enhances command readiness
- Improves retention by reducing hardship discharges
- Decreases costly overseas early returns

DD 2792-1: Special Education/Early Intervention Summary


REQUIRED for all family members under 21
