### NBIMC Welcomes CAPT Teneza-Mora

CAPT Nimfa Teneza-Mora is a native of Fort Washington, Maryland. She earned her baccalaureate degree in Aerospace Engineering cum laude from the University of Maryland College Park in 1988. She worked as a design engineer at the Naval Research Laboratory for five years. She transitioned to a career in health care after earning her medical degree from Eastern Virginia Medical School, Norfolk, Virginia in 1997 under the Health Professions Scholarship Program. She was commissioned as Lieutenant, Medical Corps, United States Navy in 1997. She complet-

ed Internal Medicine internship at Naval Medical Center Portsmouth in 1998, and served as Senior Medical Officer at Naval Weapons Station Branch Medical Clinic, Yorktown, VA from 1998-2002. She completed Internal Medicine residency at the National Naval Medical Center, Bethesda, MD in 2004. She underwent fellowship training in Infectious Diseases at Naval Medical Center San Diego from 2004-2006 and earned a Master's degree in Public Health from San Diego State University in 2008.

As staff attending physician in infectious diseases and internal medicine at the Naval Medical Center San Diego from 2007 to 2010, Teneza-Mora managed inpatient consultations, hospital admissions, and clinic patient encounters as well as trained, supervised, and mentored fellows, residents, and medical students. She served as Internal Medicine Medical Officer while deployed with the Expeditionary Medical Facility, Kuwait in 2009. She served as Internal Medicine and Infectious Diseases Medical Officer aboard the USNS Mercy TAH-19 during Pacific Partnership 2010.

In 2010, she joined the Naval Medical Research Center, Silver Spring, MD where she served as Deputy Director, Infectious Diseases Directorate during which she provided assistance to the Director by managing the daily activities of the directorate with 21 active duty service members and over 100 scientists and technicians. In 2015, she was selected as Director, Naval Medical Research Center Clinical Trials Center, and successfully led the execution of a highly complex Gates Foundation funded, multi-million dollar phase 1 clinical trial informing vaccinologists on biomarkers of protection of a promising malaria vaccine candidate.

In July 2017, CAPT Teneza-Mora served as Executive Officer of the Naval Medical Research Unit No. 6 (NAMRU-6), Lima, Peru. She managed the daily operations of the command with 13 active duty service members, four GS civilians, over 200 locally employed staff and contractors, and a \$40 M annual budget to conduct infectious diseases surveillance and medical product research and development to enhance warfighter force protection and readiness in the U.S. Southern Command Area of Responsibility. In November 2019, CAPT Teneza-Mora assumed command of the Naval Medical Research Unit Dayton (NAMRU-Dayton) in Ohio. NAMRU-Dayton conducts premier aeromedical and environmental health effects research to enhance the health, readiness, performance, and survivability of the joint warfighter. NAMRU-Dayton executes its mission with 17 active duty service members, 37 GS civilians, 90 contractors, and a \$35 M annual budget. In August 2021, CAPT Teneza-Mora will transfer to the Navy Blood Borne Infection Management Center where she will serve as Officer in Charge. CAPT Teneza-Mora maintains her board certification in Internal Medicine and Infectious Diseases.
