### **ACCIDENT PREVENTION PLAN CHECKLIST**

The Department of the Navy's February 2018 Environmental Restoration Program (NERP) Manual (Chapter 17) requires contractors, based on contract requirements, to develop site-specific Accident Prevention Plans (APPs) for environmental restoration projects. The APPs must meet the requirements of the U.S. Army Corps of Engineers (USACE) Safety and Health Requirements Manual, EM 385-1-1. The Navy and Marine Corps Public Health Center (NMCPHC) is providing the following links to the U.S. Army Corps of Engineers (USACE) Abbreviated APP Checklist (Form A-01) and the Fully-Developed Accident Prevention Plan (APP) Checklist (Form A-02).

The order of the checklists mirror the format presented in Appendix A of EM 385-1-1. Specific criteria for helping to determine whether a Fully-Developed APP or an Abbreviated APP is applicable are provided in Section 01.A.12 and Appendix A of EM 385-1-1.

These additional regulatory requirements are cited in the specific EM 385-1-1 plans and procedures referenced in the checklists. The checklists are not a substitute for the knowledge and experience of professional safety specialists and industrial hygienists. A qualified safety and health specialist and/or an industrial hygienist should carefully review each APP to determine the full scope and applicability of all regulations.
