Pre-requisites

Some courses have prerequisites to attend. Verification that applicants meet these prerequisites will be required. These courses are:

CIN: B-322-0017: DoD Pesticide Applicator Certificate Refresher (Core and Category 8). **Must recertify after 3 years.** Eligible Students: PMT's/Entomologist only.

CIN: B-322-1074: DoD Pest Management Recertification (Category 8 only). Must have current (**unexpired**) B-322-0017/1074 to attend this course. **Recertify every 3 years.** Eligible Students: PMT's/ Entomologists only.

CIN: B-322-2101: Food Safety Manager's/Supervisor's Course. Civilian attendees must provide proof of manager/supervisor status. **Recertify every 5 years.**

CIN: B-322-1100: Navy Ship Sanitation Certification Program. EHO's must complete the following prerequisites: Ship Sanitation Certification Program (NKO# CFHP-SSCEC-1.0), Health Aspects of Marine Sanitation Devices (NKO# NMCPhC-HAMSD-1.0), Shipboard Pest Management (CIN: B-322-1075), and Food Safety Manager's/Supervisor's Course (CIN: B-322-2101). Eligible Students: PMT's/EHO's only.
Certification never expires.

Core and Category 8 are offered in a single combined course to regain certification and refresh skills, knowledge, and general competencies in principles and practice of pest control and safe use of pesticides.	Certification in Category 8- Public Health Pesticide Application. Recertification is required every three years by course B-322-1074. B-322-1074 DoD Pest Management Recertification (CAT 8)	A refresher course that provides required training for recertification of DoD Pesticide Applicators Category 8 only.
