

ACADEMIC PROGRAMS DIRECTORATE (APD)

Provide leader and specialty training for officers, enlisted and civilians to develop knowledge, skills and abilities in support of warfighter requirements. Our portfolio includes:

- Advanced Readiness Officer Course (AROC),
 Basic Readiness Officer Course (BROC), Patient
 Administration Course (PAC), Financial and Materiel
 Management Training Course (FMMTC), Clinic
 Management Course (CMC), Plans, Operations,
 and Medical Intelligence Course (POMI), Advanced
 Life Support in Obstetrics (ALSO), Global Medicine
 Course, Military Tropical Medicine Course (MTM),
 STABLE Course, and Navy Medicine 101 Course.
- Predictive Index: Administer and provide analysis for Navy Medicine activities to improve teamwork, communication and productivity.

LEADER DEVELOPMENT ACADEMY (LDA)

Coordinate and execute Navy Medicine leader development initiatives in alignment with the Chief of Naval Operations (CNO) and Navy Surgeon General. Our portfolio includes:

- Facilitate milestone Leader Development Courses to include Division Officer Leadership (officer), Foundational Leader Development (enlisted), Intermediate Leader Development (enlisted) and Advanced Leader Development (enlisted) courses.
- Chair, Navy Medicine Leadership Development Advisory Council.

DIRECTORATE FOR ADMINISTRATION (DFA)

Provide administrative support for eight Directorates and over 350 staff members to include operations and materiel management, staff education and training, human resources, and information management and technology.

DIRECTORATE FOR RESOURCE MANAGEMENT (DRM)

Provide resource management support for eight Directorates and over 350 staff members to include, allocation and disbursement of funds to support mission requirements, fiscal budgeting, accounting, travel, business planning, internal control and audit compliance.

OFFICER PROGRAMS DIRECTORATE (OPD)

Provide support of Navy Medicine's Officer talent and professional development programs. Our portfolio includes:

- Provide global oversight of the Navy Medicine Graduate Medical Education (GME) residency programs to include managing Tri-Service coordination to plan, host, and execute the Joint Service Graduate Medical Education Selection Board (JSGMESB) and the Medical Education Policy Council for the Medical Corps.
- Coordinate board selection processes, provide funding, and manage execution for Graduate Professional Education (GPE) for Navy Medicine members who participate in Duty Under Instruction (DUINS) and Post-Graduate (PGY-1/PGY-2) education programs within the Dental Corps, Nurse Corps, and Medical Service Corps. Manage the Full Time Out Service (FTOS) training, Other Federal Institutions, and Full Time In Service (FTIS) Programs for the Medical Corps.
- Manage commissioning programs for Navy and Marine Corps Enlisted Personnel to include the Medical Service Corps In-Service Procurement Program and the Medical Enlisted Commissioning Program.
- Manage and administer accredited Continuing Education (CE) approval (CME, CEU, and CNE) for all Navy Medicine activities and in support of Joint and Partner facilities.
- Provide resourcing for Non-Budget Submitting Office (Non-BSO) 18 personnel seeking funding for conference and CE attendance in support of personnel readiness and sustaining currency and competency.
- Sustain the ready medical force by providing resourcing for Navy Medicine medical department military personnel to complete or renew professional credentialing requirements.

NAVAL POSTGRADUATE DENTAL SCHOOL (NPDS)

The Department of Defense's (DoD) centralized site for postgraduate dental education, delivering residency based post-doctoral specialty training and specialty board eligible training in Advanced Education in General Dentistry (AEGD-1), Comprehensive Dentistry, Endodontics, Maxillofacial Prosthetics, Oral and Maxillofacial Pathology, Orofacial Pain, Periodontics, and Prosthodontics. Additionally, our portfolio includes:

- Conduct Maxillofacial Prosthetics Technician "C" school, scholarly inquires, clinical investigations, and research in support of Postgraduate Dental Programs.
- Provide dental care to the President, Vice President, and senior Federal government civilians and military leaders.
- Faculty, Uniformed Services University of the Health Sciences (USUHS).

VISUAL INFORMATION DIRECTORATE (VID)

Provide visual information program support of Navy Medicine's readiness imaging mission to include:

- Media production (full video productions).
- Media services (live official event video documentation and audio-visual event services).
- Medical graphic arts, medical photography and project management.

TRI-SERVICE OPTICIAN SCHOOL (TOPS)

Provide formal "C" School training to Navy Opticians and Advanced Individual Training to Army Optical Laboratory Specialists through Council on Occupational Education (COE) and Commission on Opticianry Accreditation (COA) programs to support military vision readiness worldwide. Students complete a 24 weeks of training in optical theory, spectacle fabrication, and clinical procedures and earn 29 credits towards their Associate's degree upon graduation.

Faculty, Uniform Services University - College of Allied Health Sciences (USU-CAHS).
