



**Capt. Kimberly P. Toone, Medical Corps, U.S. Navy
Commanding Officer,
Navy Medicine Operational Training Command**

CAPT Toone was born in Chattanooga, Tennessee and raised in Plant City, Florida. She graduated from Plant City High School in 1989, going on to Florida State University (FSU) where she earned a Bachelor's degree in Biology in 1993. She was accepted into the Program in Medical Science (PIMS) at FSU where she earned acceptance into the United States Navy Health Promotion Scholarship Program and was commissioned in December of 1993. From there, she transferred to the University of Florida (UF) earning her medical degree in 1997.

She reported on active duty in May of 1997 as an intern in Pediatrics at National Naval Medical Center in Bethesda, Maryland, and was selected for Flight Surgery training in 1998. She earned her wings in early 1999 and reported to Naval Station Mayport, Florida where she served as a wing flight surgeon and provided medical support for the Department of Defense Manned Space Flight Program. CAPT Toone then returned to graduate medical education at Naval Hospital Jacksonville, Florida, completing a residency in Family Medicine and serving as Chief Resident from 2004-2005. Upon graduation, she reported to US Naval Hospital Okinawa, Japan deploying in 2006 to Yogyakarta (Sewon), Indonesia where she served as senior primary care provider during a humanitarian aid/disaster relief mission. Upon redeployment, she was assigned department head of Branch Health Clinic, Marine Corps Air Station Futenma and was appointed as Senior Medical Officer for the Directorate of Branch Clinics.



CAPT Toone was accepted into the Navy's Residency in Aerospace Medicine (RAM) during which she earned her Master's Degree in Public Health from Tulane University. Upon completing the RAM, she reported to USS George H.W. Bush, CVN 77, to serve as the Senior Medical Officer and Surgeon for Carrier Strike Group Two. She completed the ship's maiden deployment in support of Operations Enduring Freedom and New Dawn and earned her Surface Warfare Medical Department Officer qualification. She was then appointed as the Specialty Leader for Aerospace Medicine and Flight Surgery, assuming those duties upon transfer to Naval Hospital Pensacola, Florida in June, 2013. There she was an attending physician for the Family Medicine Residency as well as the Associate Director for Public Health during the Ebola outbreak of 2014. Departing Pensacola in July 2015, she reported to PCU Gerald R. Ford, CVN 78, as the Senior Medical Officer where she was charged with developing medical services aboard a new class of aircraft carrier and eventually became a plank owner. From there, CAPT Toone was assigned as the Force Surgeon for Naval Air Forces Atlantic where she was responsible for the medical support for all Naval Aviation assets on the east coast of the continental US.

CAPT Toone served as Executive Officer of USNS COMFORT, T-AH 20 Military Treatment Facility and cross-decked to USNS MERCY, T-AH 19 for execution of Pacific Partnership '22. She assumed command of Navy Medicine Operational Training Command on 30 September 2022.
